

## **SIGBUZZ END USER LICENSE AGREEMENT**

IMPORTANT: THIS SOFTWARE IS LICENSED TO YOU SUBJECT TO THE TERMS AND CONDITIONS OF THE FOLLOWING LEGALLY BINDING LICENCE AGREEMENT. PLEASE READ THE AGREEMENT CAREFULLY BEFORE DOWNLOADING THE SOFTWARE. IT PROVIDES A LICENSE TO USE THE SOFTWARE AND CONTAINS WARRANTY INFORMATION AND LIABILITY DISCLAIMERS. BY SELECTING TO USE THE SOFTWARE, YOU ARE CONFIRMING YOUR ACCEPTANCE OF THE SOFTWARE AND AGREEING TO BECOME BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO BE BOUND BY THESE TERMS, PLEASE DISCONTINUE USE.

### **1. OWNERSHIP AND LICENSE GRANT**

1.1 GlobalSign.In Pte Ltd ("Licensor") retains ownership of the copy of the software which you download from the Licensor's website and all other copies that you are authorised by this Agreement to make ("the Software") including without limitation all copyright and other intellectual property rights, anywhere in the world, in the Software.

1.2 Licensor grants you the non-exclusive license to install, store, access, display, run and use the Software to establish your own internet based e-commerce site only and not to provide a bureau or other service for third parties.

1.3 You may install and use the Software only on a single computer at any one time, or on one internet server hosting your website provided that the Software is used only by you or your employees as provided in Clause 1.2 above.

1.4 You may copy the Software as reasonably necessary for back-up and archival purposes, provided that each are kept in your possession, and that you reproduce the Licensor's copyright notice on each copy. You may not otherwise copy, modify, merge, disassemble or decompile the Software for any reason except and to the extent expressly permitted by applicable law.

1.5 This license is personal to you, and you may not sub-license, rent, lend or lease the Software to anyone else.

1.6 You agree that, subject to providing evidence to the contrary, the records of the Licensor's order server shall be deemed to be an accurate record of orders placed upon you by your customers using the Software. Notwithstanding the foregoing if an order is not recorded by the Licensor order server for any reason, save as otherwise expressly set out herein, THE LICENSOR SHALL HAVE NO LIABILITY TO YOU IN RESPECT OF ANY ORDERS NOT RECEIVED BY YOU.

1.7 The Licensor shall not have access to any data regarding the orders placed by your customers or data concerning your customers themselves, save as you may authorise by separate agreement.

### **2. WARRANTY AND LIMITATION**

2.1 Warranty. We warrant to you that access to the Software in accordance with its related documentation and this Agreement shall be available to you no less than 99.5% of the time during any calendar month, excluding (i) emergency or scheduled maintenance, (ii) any cause or causes beyond our reasonable control (e.g., force majeure events described in Section 6.3), (iii) the nonperformance of any hardware, software (e.g. mis-configuration of user's network environment or browser), ISP connection or other equipment that is not provided by Licensor, or (iv) Internet performance or connectivity issues outside the reasonable control of Licensor.

2.2 THE LICENSOR WILL USE REASONABLE ENDEAVOURS TO REMEDY ANY ERRORS IN THE SOFTWARE WHICH ARE NOTIFIED TO IT. THE LICENSOR DOES NOT WARRANT THAT THE SOFTWARE WILL MEET YOUR REQUIREMENTS OR THAT ITS OPERATION WILL BE UNINTERRUPTED OR ERROR-FREE. LICENSOR WILL HAVE NO OBLIGATION TO YOU FOR DEFECTS WHICH RESULT, IN WHOLE OR IN PART, FROM YOUR FAULT OR NEGLIGENCE OR THAT OF ANYONE CLAIMING THROUGH YOU OR ON YOUR BEHALF, OR FROM MODIFICATIONS MADE TO THE SOFTWARE OTHER THAN BY LICENSOR OR WITH LICENSOR'S APPROVAL, OR IMPROPER OR UNAUTHORISED USE OF THE SOFTWARE (INCLUDING THE COMBINATION, OPERATION OR USE OF THE SOFTWARE WITH EQUIPMENT, DATA, SOFTWARE OR OTHER PRODUCTS NOT SUPPLIED BY LICENSOR OR APPROVED BY LICENSOR FOR OPERATION OR USE WITH THE SOFTWARE), OR USE OF THE SOFTWARE IN A MANNER FOR WHICH IT WAS NOT DESIGNED, OR BY CAUSES EXTERNAL TO THE SOFTWARE.

2.3 TO THE EXTENT PERMITTED BY LAW, LICENSOR EXCLUDES ALL REPRESENTATIONS, WARRANTIES, CONDITIONS AND OTHER TERMS NOT EXPRESSLY STATED IN THIS AGREEMENT INCLUDING THE CONDITIONS IMPLIED BY LAW OF SATISFACTORY QUALITY AND FITNESS FOR PURPOSES.

2.4 Subject to paragraph 2.5, in no event will Licensor be liable to you for any indirect or consequential damages or losses, or any loss of profit or loss of data.

2.5 Nothing in this Agreement shall have the effect of excluding or limiting Licensor's liability for fraud or for death or personal injury caused by Licensor's negligence, or any other liability if and to the extent that the same may not be excluded or limited as a matter of law.

### **3. UPDATES AND UPGRADES**

3.1 Updates. We reserve the right to update the Software from time to time in our sole and absolute discretion to, among other things, implement bug fixes and functionality changes such as newly developed features (each, an "Update"). During the term of this Agreement, you shall receive access to all Updates without additional charge, and all such Updates shall be deemed to be Software under this Agreement. We reserve the right to render the Software and any End User Content inaccessible without notice.

3.2 Upgrades, Derivative Versions and New Products. We may, from time to time, develop (i) new versions of the Software which, among other things, implement material functionality changes (each, an "Upgrade"), (ii) a version of the Software which is implemented in a different programming language or operates on a different software or hardware platform (a "Derivative Version"), or (iii) products or services with materially different functionality ("New Products"). You shall have no rights to any Upgrade, Derivative Version or New Product under this Agreement. We may, however, from time to time during the term of this Agreement and in our sole discretion, make available to you certain Upgrades, Derivative Versions or New Products under the terms of this Agreement subject to your, or the entity's if you are using the Software as a Representative, assent to (A) any supplemental or amended terms and conditions that we require, and (B) any additional Fees that we require.

3.3 Migration. You understand and agree that certain Updates, Upgrades, Derivative Versions or New Products may require migration services in order to access your End User Content using such Updates, Upgrades, Derivative Versions or New Products. We may, in our sole discretion, require additional Fees to perform these migration services. We also may, in our sole discretion, give you the choice of either (A) paying such additional Fees for such migration services, or (B) continuing to use the Software without such Updates, Upgrades, Derivative Versions or New Products.

#### **4. CONFIDENTIAL INFORMATION**

4.1 All information, data, drawings, specifications, documentation, software listings, source or object code which the Licensor may have imparted and may from time to time impart to you relating to the Software (other than the ideas and principles which underlie the Software) is proprietary and confidential. The Licensee hereby agrees that it shall use the same solely in accordance with the provisions of this Agreement and that it shall not at any time during or after expiry or termination of this Agreement, disclose the same, whether directly or indirectly, to any third party without the Licensor's prior written consent.

4.2 Subject only to the specific, limited provisions of Clause 3.1 above, you further agree that you shall not yourself or through any subsidiary, agent or third party use such confidential information to copy, reproduce, translate, adapt, vary, modify, decompile, disassemble or reverse engineer the Software nor shall you sell, lease, license, sub-license or otherwise deal with the Software or any part or parts or variations, modifications, copies, releases, versions or enhancements thereof or have any software or other program written or developed for yourself based on any confidential information supplied to you by the Licensor.

4.3 The foregoing provisions shall not prevent the disclosure or use by you of any information, which is or hereafter becomes, through no fault of the Licensor, public knowledge or, to the extent permitted by law.

#### **5. INDEMNIFICATION.**

5.1 You, or the Entity if you are using the Software as a Representative, shall indemnify Licensor and its officers, directors, shareholders and employees (each a "Licensor Indemnified Party") against any and all harm, claims, losses, costs and expenses, including attorneys' fees, which a Licensor Indemnified Party may incur as a result of claims in any form by third parties arising from or relating to (a) any End User Content (including any content on any web site to which any End User Content is hyperlinked) , (b) your use of the Software, (c) your acts, omissions or representations, and (d) any content contained on your web sites.

#### **6. GENERAL PROVISIONS**

6.1 Severability; Headings. If any provision herein is held to be invalid or unenforceable for any reason, the remaining provisions will continue in full force without being impaired or invalidated in any way. Headings are for reference purposes only and in no way define, limit, construe or describe the scope or extent of such section.

6.2 Export Control. You will comply with all applicable export and import control laws and regulations applicable to use of the Software. You, or the Entity if you are using the Software as a Representative, hereby agree to defend, indemnify and hold harmless Licensor from and against all breaches of this Section.

6.3 Force Majeure. Except for the payment of monies due hereunder, neither party shall be responsible or have any liability for any delay or failure to perform to the extent due to unforeseen circumstances or causes beyond its reasonable control, including, without limitation, acts of God, earthquake, fire, flood, embargoes, labour disputes and strikes, riots, war, Internet or other network "brownout" or failures, telecommunications provider failures, power failures, hacker attacks, computer viruses, and acts of civil and military authorities. Each party acknowledges that the operation of Licensor's servers and the provision of the Software may be interfered with by numerous factors outside of Licensor's control.

6.4 Entire Agreement. This Agreement constitutes the entire agreement between you and Licensor (or you, the Entity and Licensor if you are using the Software as a Representative) with respect to the subject matter hereof and neither party shall be liable to the other in any manner for any representations, warranties or covenants except as specifically set forth herein
